## Principal Lecturer (Ref: 2500252) Department of Curriculum and Instruction Faculty of Education and Human Development

The appointee will play a pivotal role in providing effective leadership in programme and curriculum development, quality assurance and continuous improvement of learning and teaching within our University in the area of a) curriculum and assessment; b) teaching both in and beyond the classroom in diverse educational settings; c) Professional and Vocational Education. In addition to course teaching, the appointee will participate in activities related to project supervision, field experience supervision, internship supervision, guidance to students in the capacity of personal tutors, and so on. The appointee is expected to contribute to curriculum and programme development, programme and course management and partake in departmental activities and represent the Department in meetings and various boards and committees, and provide good service contributions to the University and the community.

Applicants for the post of Principal Lecturer should have a Master's degree in a relevant subject discipline plus a minimum of 15 years' relevant post-qualification teaching / professional experience; or preferably a Doctoral degree plus a minimum of 6 years' relevant post-qualification teaching / professional experience. Possession of a relevant professional teaching certificate, e.g., PGDE or qualification of Qualified Teacher Status (QTS) recognized by the Education Bureau of Hong Kong or other qualification of equivalence will be an asset. Applicants possessing relevant teaching and professional experience in the fields of Professional and Vocational Education at tertiary education setting are highly preferred. Applicants should have demonstrated effective leadership and a high level of management responsibilities for co-ordination and advancement of teaching and learning initiatives such as curriculum design and planning, programme administration, quality assurance, etc. Experience and effectiveness in working in students affairs will be an advantage. Priority will be given to applicants who can teach in multiple mediums of instruction (English, Cantonese, and Putonghua).
