Project Title: Making Sense of 'Community' in Social Entrepreneurship through an Embeddedness Lens

[Appointment Period: 12 months]

The appointee will join a multidisciplinary team to investigate how social enterprises are embedded in and shape their understanding of communities. This project explores the reciprocal relationship between social entrepreneurship and community places using qualitative, computational linguistic, and comparative case analysis methods. The appointment will be for a period of 12 months, with the possibility of renewal subject to performance and mutual agreement.

Duties and Responsibilities:

- Coordinate and oversee subject recruitment and fieldwork activities (e.g., interviews, walking interviews, shadowing)
- Manage qualitative, computational, and survey-based data collection, ensuring data quality and integrity
- Conduct in-depth data analysis (including coding, thematic analysis, QCA, and statistical analysis)
- Design questionnaires and support field survey administration
- Help draft research proposals for both internal and external competitive funding opportunities
- Contribute significantly to manuscript drafting and collaborative academic publications
- Support the PI and Co-PI in managing research timelines, team coordination, and stakeholder engagement
- Assist in knowledge transfer activities and conference presentations

Qualifications and Requirements:

- A PhD in Sociology, Social Policy, Public Administration, Urban Studies, Entrepreneurship, Human Geography, or a related field (PhD completed or near completion)
- Strong experience in both qualitative and quantitative research methods
- Prior experience in proposal writing and conducting field-based studies
- Familiarity with qualitative analysis tools (e.g., NVivo, Atlas.ti) and basic statistical analysis software (e.g., SPSS, Stata, or R)
- Knowledge of Hong Kong's social enterprise sector or community-based initiatives is a plus
- Excellent command of English (and ideally Cantonese) for research communication and participant interaction

Desirable:

- Demonstrated ability to contribute to academic writing and publishing
- Background in (social) entrepreneurship or community development
- Experience using R and/or Python for text analysis, topic modelling, or other computational techniques is highly desirable
- Passion for engaging with local communities and conducting field-based, participatory research
