The National Security and Legal Education Research Centre (NSLERC) of the Academy for Applied Policy Studies and Education Futures (AAPSEF) is seeking an inspirational and energetic candidate for the position of Lecturer I/II to support its expanding scope of learning and teaching and other initiatives. This is an exciting opportunity for individuals who wish to contribute to dedicated teams and advance their careers in higher education.

The appointee will join the vibrant NSLERC team to deliver a variety of learning and teaching activities in programmes, e.g.: Master of Laws in Digital Governance [LLM(DG)]. Responsibilities mainly include: i) Undertaking teaching duties at undergraduate and/or postgraduate levels, and/or supervising postgraduate students; ii) Formulating strategies for the development of NSLERC as well as AAPSEF that are in alignment with the strategic direction of the University; iii) Overseeing the planning and execution of various initiatives, events, and programmes to ensure they achieve the KPI's set out for them; iv) Supporting the development of NSLERC, working closely with the committees of NSLERC, AAPSEF and the University; v) Developing and maintaining strategic partnership of NSLERC with stakeholders both Faculties and Departments within the University, and external parties including but not limited to donors and service users; and vi) Contributing to curriculum and programme development, programme and course management and partake in the NSLERC's activities and represent programme(s) in meetings and various boards and committees, and provide good service contributions to the University and the community.

For the post of Lecturer I, applicants should have a Master's degree in Laws, preferably with a Doctoral Degree, plus a minimum of 4 years' relevant post-qualification teaching experience in the subject applied for. Applicants with less teaching experience may be considered for the post of Lecturer II.

They should have a strong command of both written English and Chinese. Proficiency in spoken English and Putonghua is a must. They should be self-motivated, with strong problem-solving, communication, project management, and organisation skills. Immediate availability is preferred.
