Applicants should demonstrate proven professional experience in schools, NGOs, and/or teaching experience in tertiary education. Candidates should be fluent in English, Cantonese, and Mandarin Chinese, and have an understanding of the educational context of Hong Kong and/or Mainland China. The ability to teach through more than one medium of instruction (English/ Cantonese/ Mandarin Chinese) would be an advantage.

Applicants should hold a Doctoral degree (EdD or PhD) with substantial post-qualification teaching experience in a tertiary education setting, and preferably possess a relevant professional teaching qualification, such as a Postgraduate Diploma in Education (PGDE) or Qualified Teacher Status (QTS) recognised by the Education Bureau of Hong Kong, or an equivalent qualification.
